- Matches and candles in a metal box or plastic bag useful to warm you up, to warm up a drink or for light
- Blankets

- Road maps
- A few quarters and one dollar coins or a calling card if you do not have a cell phone

Since 1987 we have been an integral part of the community, and we have saved thousands of abandoned dogs & cats, and found them truly wonderful forever homes!! Our commitment to the well-being of these animals goes above & beyond.

Every animal that arrives at our doorstep is taken in & treated with loving care. Before these animals get put up for adoption they are vetted, given the appropriate shots, and spayed or neutered.

Each day they are fed twice, the dogs are walked & allowed playtime in our dog park, the cats have their own outdoor exercise area, and at night they are warm and cozy in the Shelter accommodation.

A new refuge for the Eastern Townships SPA

The Eastern Townships SPA has now opened the doors of its brand new shelter, located at 145 Sauvé street in Sherbrooke. This new space, being twice as large as the old one, will offer optimal living conditions for all its four-legged residents, as well as offering them twice as much comfort. The main objective of this project was to improve the conditions of care for animals being housed within the shelter, and this, by building environments according to the specific needs of each species. In order to facilitate adoptions, the new shelter will offer more friendly and warm adoption areas. All this will help to reduce the animals' stress and improve their quality of life. Changes to the Animal Bylaw

The Municipality of Ogden wishes to advise its residents of significant changes to the *Bylaw Respecting Animal Care and Control* which were recently adopted in Ogden. The following are excerpts from the new bylaw:

Biological imperatives: The biological imperatives of an animal are those related to its breed, type of fur, age, growth stage, size, level of physical activity, health status, whether it is pregnant or lactating, as well as those facts related to its degree of adaptation to cold or heat (section 3 t)).

Vital needs: The guardian must provide the animal in his care with drinking water and food that is healthy, fresh and free of contaminants, including feces, urine or litter (section 7).

Biological imperatives: The biological imperatives are as defined in section 3 t) of this bylaw. Snow and ice are not sources of drinking water that meet an animal's biological imperatives (section 7.1).

Cleanliness: The building, cage, enclosure, park, kennel or shelter serving as such, and the immediate environment of the animal, as well as the equipment and the accessories which are found there, must be kept clean and exempt of waste, including feces and urine (section 7.2).

Safety: The cage, enclosure, park, kennel or shelter serving as such, and the immediate environment of the animal, must be free from any product, object or material likely to jeopardize its safety (section 7.3).

Resting area: At all times, the animal must have access to a dry, clean, full, comfortable resting area of sufficient size to allow it to lie on its side, with limbs fully extended. This area must be protected from elements that may cause stress to the animal or affect its health, such as adverse weather, sun, drafts, excessive noise or harmful gas (section 7.4).

Outdoor dog shelter: Any dog housed primarily outdoors must have access to a kennel, or a shelter serving as such, that meets the following requirements:

- 1) It is made of non-toxic materials, durable and resistant to corrosion;
- 2) It is constructed of insulating material to ensure that the animal is protected from adverse weather and the cold:
- 3) Its roof and walls are waterproof, its floor is raised, its entrance is always accessible;
- 4) It is in good condition, free of protrusions, sharp edges or other sources that may cause injury:
- 5) It is sturdy and stable;
- 6) Its size allows the dog to turn around and also to maintain its body temperature in cold weather:
- 7) It is situated in a shady area with little wind, snow or rain (section 7.5).

Outdoor dog enclosure: An outdoor enclosure must meet the following requirements:

- 1) Its construction is intended to prevent the escape of the animal as well as injury or stress caused by another animal that is not kept in such enclosure;
- 2) Its ground drains easily;
- 3) The floor area must be equivalent or greater, in square meters, to the result of the following equation: 9 X L2: L = length of animal measured from snout to base of tail;
- 4) The covered area must be large enough to protect the animal from bad weather as well as from the adverse effects of the sun;
- 5) The posts and screens forming its enclosure, if any, or any of its other components, are in good condition, free from protrusions, sharp edges or other sources that may cause injury;
- 6) It is positioned at a minimum distance of 1 meter from any lot line (section 7.6).

Changes to the Animal Bylaw (cont.)

Restraints: Any restraining device, including a chain or a rope, used to tether an animal outdoors shall comply with the following requirements:

- 1) It has a minimum length of 3 meters and is installed so that the animal cannot leave the property of its guardian;
- 2) It is strong enough to restrain the animal according to its size and weight;
- 3) It is not likely to get caught or shortened, especially when wrapping around an obstacle;
- 4) It does not cause discomfort to the animal, especially because of its weight;
- 5) It allows the animal to move without danger or constraint;
- 6) It allows the animal to have access to its water and food.

The period of restraint must not exceed 6 consecutive hours between the times of 6 am to 11 pm and must not exceed 30 minutes between the times of 11 pm to 6 am, except if someone is outside with the animal and less than 25 meters from it (section 7.7).

Outdoor dog care: Only dogs whose biological imperatives (see definition at section 3 t) of this bylaw) allow it may be kept primarily outdoors, provided that all sections of this bylaw are met (section 9).

Outdoor shelter: The keeper of an animal kept outdoors must provide it with a shelter appropriate for its species and the weather. The shelter must comply with the following minimum standards:

- a. It must efficiently protect the animal from the sun, rain, snow and wind;
- b. It must be waterproof, insulated from the ground and constructed with insulating materials:
- c. Its size must be adequate for the size of the animal so that the animal may conserve its body heat (not too large) (section 9.1).

Dogs outside during cold weather: In accordance with its biological imperatives, a dog can stay outside from 5 minutes to a maximum of 3 hours during very cold weather unless a veterinarian confirms that the shelter, the type of dog, the health of the dog and its other biological characteristics allow that this period be lengthened while protecting the comfort and the well-being of the dog. The veterinarian must also specify the acceptable length of time the dog can be kept outdoors, depending on the outside temperature, however this length of time cannot exceed 9 hours per period of 24 hours (section 9.2).

Dog left unattended: It is forbidden to leave a dog alone and unattended for a period exceeding 12 consecutive hours. The guardian must mandate a responsible person to provide the animal with water, food and all the care required in accordance with its age and breed (section 9.3).

Thank you for making sure that you comply with the *Bylaw Respecting Animal Care and Control*... it's for the well-being of Ogden's pets!
