Public notice to interested persons entitled to sign an application to participate in the procedure for approval by qualified voters with respect to the second draft of By-law No. 2022-05 amending Subdivision By-law No. 2000-4

Take notice that on February 7, 2022, the Council of the Municipality of Ogden adopted the second draft of *By-law No. 2022-05 amending Subdivision By-law No. 2000-4*.

A copy of the summary of the second draft may be obtained, free of charge, by any person upon request at the municipal office.

This second draft by-law contains provisions that may be the subject of an application by interested persons in Zones 10R, 12RV, 13RV, 25RV and 26RV within the territory of the Municipality, in order that the by-law be submitted for the approval of persons qualified to vote, in accordance with the *Act respecting elections and referendums in municipalities*.

Every such application shall be for the approval of the by-law containing provisions respecting the affected zones by the qualified voters of the zone or zones to which the provisions apply and of the qualified voters of any contiguous zone from which a valid application in respect of such provisions is made.

Information as to which interested persons are entitled to sign an application, with respect to which provisions of the second by-law such application may be made, and the purpose of such application, is available at the Municipal office.

To be valid, an application must: (i) clearly indicate the provision from which it is made and the zone from which it originates, (ii) be received at the Municipal office no later than March 3, 2022, and (iii) be signed by at least 12 interested persons from the zone from which it originates or by at least a majority of them if the number of interested persons in the zone does not exceed 21.

Information to determine which interested persons are entitled to sign an application, the number of signatories required and the manner in which a corporation may exercise the right to sign such an application, may be obtained at the office of the Municipality during normal business hours.

The zones affected by this project are 10R, 12RV, 13RV, 25RV and 26RV. The illustration of the zones concerned as well as the contiguous zones can be consulted at the office of the Municipality.

All provisions of the second draft by-law that have not been the subject of a valid application may be included in a by-law that does not have to be approved by persons qualified to vote.

The second draft by-law is available at the municipal office and a copy may be delivered upon payment of the prescribed fee.

Any document available at the municipal office may be obtained by visiting 70 Ogden road, Ogden, during regular business hours.
